WIL President Thaima Samman opened the event, thanking our partners and introducing the distinguished speaker, EVP Dombrovskis, before moderating the exchange. She set the scene, noting that international trade had been key for peace and prosperity since WWII, but that the last ten years had seen the emergence of big players from Asia, Trump's election, Brexit and of course the Covid-19 crisis. Was trade still key for peace and prosperity or did it need to adjust? What could we expect from the US-EU relationship in the coming period?

Drawing on her experience in decarbonisation, Dorothée Coucharrière from our Event Partner, Fipra, recalled that sustainability was at the centre of the Commission's open strategic autonomy policy, and questioned the EVP on how this would translate into companies' value chains so that the EU Green Deal's objectives were effectively achieved in a fair and competitive manner.

Executive Vice-President Dombrovskis highlighted the key elements of the Commission's Trade Policy Strategy for the coming decade. It would be reaffirm the EU's commitment to free and fair rules-based trade as an important driver of global prosperity, including through reform of the World Trade Organisation ("Open"); be a vehicle to achieve the EU's sustainability goals, with adherence to the Paris agreement and commitment to climate neutrality an essential element in future free trade negotiations ("Sustainable"); and more assertive in defending EU interests and acting unilaterally where other countries refused to play by rules, including through the creation of a new position of Chief Trade Enforcement Officer ("Assertive").

The world has definitely evolved in the last decade.
There are new challenges and a new geopolitical landscape, and we in the EU need to be able to react to this.
